

Foster Agreement

General:

This bitch/puppy (now referred to as "dog") will reside with the Foster Home except when needed to travel to the Breeders for the purpose of breeding clearances and actual breeding and commencing one week prior to whelping and approximately 7 weeks following whelping.

The Foster Home will keep the Breeders up to date on the development of the dog and inform the Breeders when the dog comes into heat each time.

The Foster Home will be smoke free.

As noted above, this dog will be returned to the Breeders one week prior to the whelping date and stay with the Breeders for up to 7 weeks.

The Foster Home will keep this dog with full regard to safety, health, mental well being, socialization and training needs and in physical condition for breeding. This dog will not be tied up nor let run loose. When in heat, she will be kept safely on lead or at home to avoid unwanted matings.

This dog will not be bred until her second heat and will not have more than 4 litters.

If the Foster Home decides to purchase a pup from any one of the litters, they will be given second or third choice after the Breeders.

If the Breeders decide, on the advice of their veterinarian, future pregnancies will be harmful to the dog, the dog will be withdrawn from the Breeding Program. After being spayed, at the Foster Home's expense, ownership will be transferred to the Foster Home.

During pregnancy, the Foster Home will follow all health instructions from the Breeders. If any additional vitamins or supplements are necessary, they will be supplied at the Breeders' expense.

Should the dog's health clearances not be satisfactory prior to the first breeding then the Foster Home will spay the dog and pay a nominal fee of \$400.00. The Breeders then will transfer ownership to the Foster Home.

Recalled:

The Breeders will insist on the dog being returned if it is learned she is allowed to run loose without supervision; if she is accidentally bred; if the Foster Home fails to inform the Breeders of the dog's heat cycles; if the dog becomes so overweight that her health is at risk, if the Foster Home does not return phone calls or emails from the Breeders within a reasonable time.

Costs:

The Foster Home will not pay the Breeders for the dog unless as stated above.

All cost of routine care (good quality food –Nutro/Natural Choice/Large Breed/Adult/Puppy, shelter, training, routine and emergency veterinary services) will be at the expense of the Foster Home.

If the Foster Home decides to enter her to receive her title – cost of the entry fee for the CKC events including confirmation shows, obedience trails, WC hunt test etc. will be shared between them both. Should the Breeder decide to enter her to receive any of the above titles, the cost of the entry fees will be the Breeders' responsibility.

Cost of annual eye exams, PennHip, OVC hip and elbow certifications, stage cycle tests will be at the Breeders' expense.

Other:

Before a family will be considered for the program, the Breeders must meet all the members of the family that will be living in the household.

If, for whatever reasons, the Foster Home can no longer care for the dog while she is in the breeding program, she is to be immediately returned to the Breeders.

If, at the Breeders' discretion, the dog is removed from or has completed the Breeding Program after being bred, the dog may live permanently with the Foster Home on the condition that she is spayed at the Foster Home's expense. Ownership will be transferred into the Foster Home's names. Transfer of ownership fees will be at the Breeders' expense.
